

Integrated Faxing


Integrated Faxing provides the capability to send internet faxes directly out of FactorSoft. When the Internet Faxing option is configured, you can generate reports and statements out of FactorSoft using the Fax (or **Preference**, assuming the preference for the customer/debtor is set to **Fax**) **Output** media options and output the report as a fax through the Integrated Fax Service.

System Preferences

To activate Integrated Faxing, a valid license key must be configured in System Preference Identification/system constants, FDS Services, Fax parameters folder, as shown below. For more information on obtaining licensing, contact your FactorSoft Support Representative at 800-365-4091, option 2.

Field	Description
Internet Fax Sub- scription	Enter the internet fax subscription key.
Use Internet Fax	Set to True to enable internet faxing.
Internet Fax file path	Set the folder location for the intermediate file location to which fax documents are written prior to delivery via internet fax.
	This can be any folder location, provided the folder is already created and the Engine has access to the folder.



Engine Tasks

The Engine enables the alert monitoring functionality of Integrated Faxing. The service task **Send Fax** must be configured in the in the Administration module and the Engine task **Faxes** enabled in the Engine Administration module.
